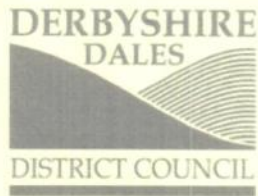

**SCRAP METAL DEALERS ACT 2013**  
**MOBILE COLLECTOR'S LICENCE**

Mr John Douglas Partridge of this company was granted a licence to collect scrap metal by Derbyshire Dales District Council on **7<sup>th</sup> August 2019** for a period of 3 years. See certified copy of Collector's Licence.

The Scrap Metal Dealers Act 2013 (Section 10) requires that when we are operating in Derbyshire Dales District Council's area our Collector's Licence must be placed in the windscreen of any of our vehicles where it can be clearly read by anyone outside the vehicle. Failure to comply with this requirement is an offence under the Act and the maximum penalty for this is currently a Level 3 fine.

This Licence authorises Mr John Douglas Partridge of Peak Waste Recycling Limited, Wood Lane, Kniveton, Derbyshire, DE6 1JL, to operate as a scrap metal collector in the Derbyshire Dales and allows him to authorise others in his employment to collect on behalf of the company.
